Re: Transmittal of Arkansas's 2020 Section 303(d) List

Dear Ms. Taylor:

The U.S. Environmental Protection Agency (EPA) has completed its review of public comments received on its September 28, 2023, action partially approving and partially disapproving the State of Arkansas's 2020 Clean Water Act Section 303(d) List of Water Quality Limited Segments (WQLSs) still requiring Total Maximum Daily Loads. After considering the public comments received, the EPA is affirming its September 28, 2023, action adding 7 additional waterbody/parameter pairs to the State of Arkansas's Section 303(d) list and forwarding the final list to the state to incorporate into its current water quality management plan.

Comments received during the public comment period and the EPA's responses to comments can be found in Enclosure 2 titled *EPA Additions to the Arkansas 2020 Impaired Waters List – Response to Public Comments* and Enclosure 3 titled *Comments Received by The U.S. EPA On EPA's Additions to Arkansas's 2020 Impaired Waters List*.
